Individuals and organizations in Argentina (Cuil or CUIT), Brazil (CPF or CNPJ), Chile (RUT), and Colombia (RUT or NIT) are required by law to provide a tax identification number. You may provide it on this form or directly to your staff liaison.

A W-9 form is required for all Rotary vendors with a U.S. tax ID. A Certificate of Foreign Status form is required for all non-U.S. vendors. If you are a new vendor or your withholding information has changed, please include your most recent W-9/foreign status form with this payee form. Note: We may require additional documentation based on the information provided in the W9/foreign status form.
